## INSTRUCTIONS USE THE WORKSHEET BELOW FIRST

- Line 1 Enter the total dollar amount of fees collected during the period (from (A) below). If no tires were sold during the period covered, enter zero in the space provided.
- Line 2 Enter the total number of tires sold (from (B) below).
- Line 3 Multiply the number of tires on Line 2 by 0.10 per tire. (An accounting allowance of 10 cents per tire is allowed)
- Line 4 Subtract Line 3 from Line 1. This is the amount due to the Arizona Department of Revenue for the period covered.
- Line 5 Enter the amount of your remittance. Please make sure your check or money order amount matches the amount on Line 4.

  If they do not match, attach notification of adjustment or a letter explaining the difference.

The Waste Tire Fee is required to be collected by sellers of new motor vehicle tires in Arizona. ARS Title 44, Chapter 9, Article 8. TIRES SUBJECT TO FEE All new tires sold for on-road vehicles. **AMOUNT OF FEE** 2% of the retail sales price, not including sales tax, of each tire to a maximum of \$2 per tire. **EXCEPTION** For sales of new motor vehicles with a gross weight under 10,000 pounds, if the sales price of the tires is not separately stated, the amount of the fee is \$1 per tire. If the price is separately stated, the waste tire fee is 2% of the tire price to a maximum of \$2 per tire.
