Instructions for Form D-400V, Payment Voucher

What Is Form D-400V and Why Should You Use It?

It is a statement you send with your payment of any balance due on your 2007 Form D-400. Using Form D-400V allows us to process your payment more accurately and efficiently. We strongly encourage you to use Form D-400V.

Preparing and Sending Your Payment

- **Be sure to enter your social security number(s) in the boxes provided.**
- Make your check or money order payable in U.S. dollars to the **NC Department of Revenue**. **Note:** The Department will not accept a check, money order, or cashier's check unless it is drawn on a U.S. (domestic) bank and the funds are payable in U.S. dollars.
- Make sure your name and address appear on your check or money order.

- Enter "2007 Form D-400," your daytime phone number, and your SSN on your check or money order. If you are filing a joint return, enter the SSN shown first on your return.

- Mail your return, payment, and Form D-400V in the envelope that came with this booklet.

What if You File Electronically?

If you choose to file electronically and have a balance due, follow your transmitter's or preparer's instructions for making your payment.

Other Payment Methods

Important Reminders

- **Do not** staple, tape, paper clip, or otherwise attach your check or money order to the voucher.
- **Do not** fold the voucher or check.
- **Do not** use the voucher if any of the preprinted information does not match what you entered on your return. Instead, go to our website to generate a personalized D-400V with the correct information.
- **Do not** use the voucher to pay quarterly estimated tax.
- **Do not** use a photocopy of the voucher.
- **Do not** use another person's voucher.
- **Do not** send cash.
